Dear Members of the Wisconsin Congressional Delegation,

The undersigned Wisconsin professional organizations and pediatric health care providers write to express our support for strengthening the federal response to the current mental and behavioral health crisis facing our children. Specifically, we ask that you work with your colleagues and House and Senate Leadership to prioritize and advance bold legislation this year that includes proposals that provide tailored and dedicated support for children's mental and behavioral health.

As recently highlighted on 60 Minutes, children and adolescents in Wisconsin and across the nation are facing a mental and behavioral health crisis that existed prior to the pandemic and has worsened due to the added stress of the last two years. According to Wisconsin's Office of Children's Mental Health, one in five Wisconsin children have a diagnosable mental illness and approximately 40 percent are not accessing treatment. A recent analysis of health plan claims data showed that Wisconsin is in the top five states in the nation for the most intentional self-harm claims among those ages 6 to 22. Providers on the frontlines are seeing increases in the number and acuity of kids who present with primary and secondary mental and behavioral health complaints in their offices. In Wisconsin, nearly every statistic you look at related to mental health tells us our children are suffering.

As stakeholders committed to improving access to mental and behavioral health services for children in the state, we have made progress in expanding access to care, including in schools and pediatrician offices, and funding initiatives to grow our own workforce. Yet, the increased demand for mental and behavioral health services has stressed already inadequate and under-resourced systems, leaving far too many children waiting for desperately needed services at all levels of care. It is clear that existing federal programs are insufficient to address the scale of the national children's mental health crisis. More must be done to support children's access to the right care, in the right setting, at the right time.

We ask that you ensure that any legislation advanced this year includes purposefully designed and tailored investments to: bolster the pediatric mental and behavioral health workforce; promote integration of mental and behavioral health services across a variety of settings; and strengthen systems of care to ensure children have timely access to culturally and developmentally appropriate mental and behavioral health services across the care continuum. To transform the system of care for children, we need policies to ensure payer compliance with parity laws and increased investments in the Medicaid program, the largest payer of pediatric mental and behavioral health services, to ensure providers can continue working to meet the mental and behavioral health care needs of children.

It will take partnership, collaboration and investments from all stakeholders to address the urgent needs of our children. We must collaborate to ensure the kids in the state receive the supports and health care they need to thrive into adulthood. We urge you to work with your colleagues to ensure that federal policies are advanced in support of our shared goal of improving the mental and behavioral health of our children.
